## 2018 Retrospective

2018 brought exciting new changes and opportunities to US/ICOMOS, including a new Executive Director, Jane I. Seiter, Ph.D., who joined us in August; a move to new offices at 1602 L Street NW in Washington, DC, in September; and a very successful Symposium and Soirée in San Francisco in November. Here are some of the highlights of the year:

**All Year:** We kicked off the year with an Introduction to [ICOMOS International Scientific Committees](#) (ISCs) in our January *Members' Newsletter* and followed this with monthly interviews with US-based ISC leaders in *US/ICOMOS at Work*. **January, Puerto Rico:** then-Executive Director Bill Pencek joined [ICOFORT](#) President and US/ICOMOS member Milagros Flores Román for a series of meetings and site visits to provide a sense of the challenges confronting those working on the front lines in Puerto Rico and to identify how US/ICOMOS and ICOMOS might assist. **March, Charlottesville, VA:** US/ICOMOS was proud to co-sponsor "Interpreting and Representing Slavery and its Legacies in Museums and Sites: International Perspectives," a conference at the University of Virginia and Thomas Jefferson's Monticello. The conference brought experts from more than 20 nations to share and discuss methods and approaches, including members of UNESCO's [International Scientific Committee of the Slave Route Project](#). **April, online:** US/ICOMOS partnered with the National Park Service (NPS) in a 24-day celebration of World Heritage in the US beginning on April 18th, World Heritage Day. 2018's theme was #Heritage4Generations. 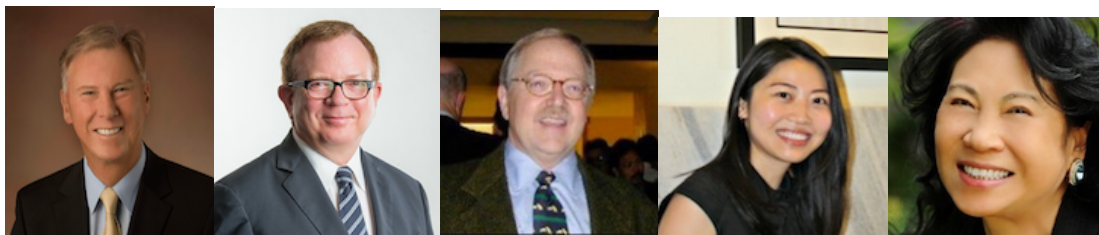

US/ICOMOS President Doug Comer and other ICOMOS national committee leaders met with the Africa Unit of the World Heritage Center and the African World Heritage Fund regarding the development of partnerships with universities that instruct in English to further heritage preservation in Africa. US members also participated in forums dedicated to Climate Change and World Heritage and forming an ICOMOS Indigenous Culture Working Group.

**July, Washington, DC:** US/ICOMOS paid a very fond farewell to Executive Director Bill Pencek, pictured below left at the Grand Canyon, and warmly welcomed new Executive Director, Jane I. Seiter, Ph.D., pictured below right in Baltimore.



**August, Washington, DC:** the IEP participants convened in Washington for the IEP Symposium after completing their internships. They also toured Baltimore and celebrated their accomplishments with US/ICOMOS IEP Committee members, trustees, program sponsors and members at the IEP Closing Reception. ## 2019: The Year Ahead

**All year:** Despite the formal withdrawal of the United States from UNESCO at the end of 2018, the United States remains a signatory to the World Heritage Convention. This provides us with the basis for continuing constructive involvement in programs activities that will advance preservation of world cultural and natural heritage. US/ICOMOS has been very active in pursuing dimensions of this involvement that provide increasing benefit to communities the world over. We can see this in our leadership in the culture-nature journey and our increasing advocacy for indigenous heritage groups as traditional stewards of natural and cultural resources. In 2019, we will enhance working relationships with ICOMOS national and scientific committees in order to move forward toward the broad goals of the World Heritage Convention and remain an active participant in World Heritage. The role of US/ICOMOS within the US is more important than ever in advocating for the significance of heritage conservation at the national and international levels. We take this mission very seriously and hope that you, our members, will assist in our advocacy and all other efforts.

**January:** US/ICOMOS Trustees have instituted a new Action Committee structure for organizing the activities of US/ICOMOS in 2019 and beyond. Trustees will devote their time and talents to Development, Communications, Programs and other specialized committees in order to sustain and foster US/ICOMOS and World Heritage in the US and to support US/ICOMOS's small staff.

**Communications:** We have committed to updating and improving the US/ICOMOS website; increasing the frequency of our posts on social media; and to introducing our members to our IEP sponsors via our US/ICOMOS at Work monthly e-blasts in 2019.

**January - August:** International Exchange Program 2019. Hosts have been chosen and applicants are under review now. Invitations will go out in early February with the goal of finalizing internships by mid-March. Please consider [supporting us](#) in this singular international educational exchange program!

**April:** US/ICOMOS will celebrate World Heritage Day on April 18th with a lecture at the National Building Museum and with renewed focus on [WorldHeritageUSA.org](http://WorldHeritageUSA.org). Look for more information soon.

**May:** the Gala Celebration of World Heritage will be held at the Cosmos Club in Washington, DC, on 2 May 2019. This is our most important fundraiser of the year and its success is crucial to the organization. We will celebrate US World Heritage, award the Murtagh|Graham Prize to a young professional, and honor major accomplishments in the US/ICOMOS family. We hope that you will [attend](#) or [make a charitable contribution](#) to support our efforts.

**June - July:** The 43rd session of the World Heritage Committee will be held in Baku, Azerbaijan, from 30 June to 10 July 2019. The [20th-Century Architecture of Frank Lloyd Wright](#) World Heritage nomination has been submitted for consideration: we are hoping that these 8 works of modern architecture will be recognized for their Outstanding Universal Value and inscribed on the World Heritage list.

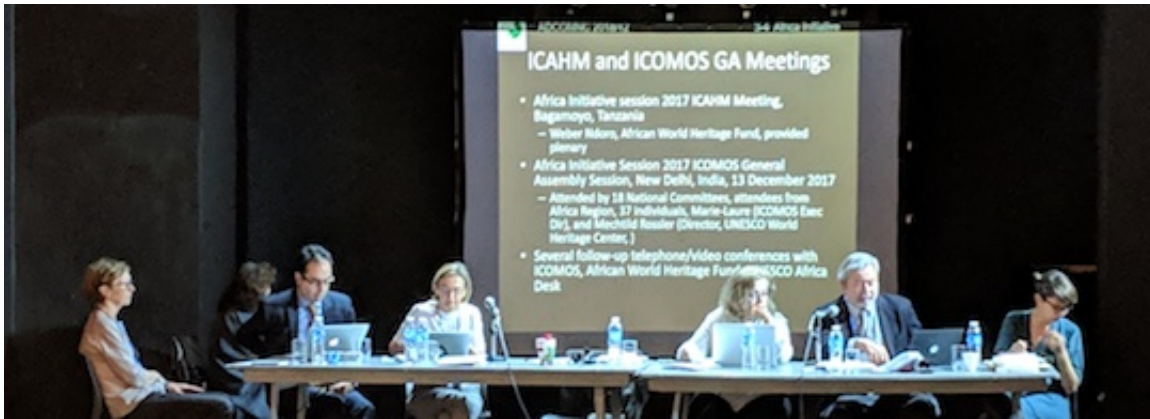
**November/December:** US/ICOMOS will hold a Member Symposium in Washington, DC. Date and location to be announced soon.

## Buenos Aires Declaration Marks the 70th Anniversary of the [Universal Declaration of Human Rights](#)

In celebration of the 70th anniversary of the Universal Declaration of Human Rights, ICOMOS adopted the [Buenos Aires Declaration](#) entrenching Human Rights into cultural heritage activities.

ICOMOS supports the right to enjoy and partake of cultural heritage and reiterates its commitment to supporting Rights Based Approaches to World Heritage. ICOMOS has taken important initiatives over the last decade to respect, protect and fulfil the rights to culture for individuals and communities by including Rights Based approaches in its work, through its *Ethical Principles* and the *Our Common Dignity* Initiative.

ICOMOS members, Committees and groups are therefore encouraged to:

- Build strong relationships with communities and peoples in their work
- Embrace the principle of free, prior and informed consent of source communities before adopting measures concerning their specific cultural heritage
- Offer all possible assistance so that communities and right holders are consulted and invited to actively participate in the whole process of identification, selection, classification, interpretation, preservation and safeguarding of, as well as the stewardship of and development of cultural heritage.

### Zero Draft of the CCHWG's [Outline of Climate Change and Cultural Heritage](#) Deadline for US National Committee Comments: 20 Feb 2019

Dear ICOMOS National Committee and International Scientific Committee leaders,

I am writing on behalf of the [ICOMOS Climate Change and Heritage Working Group \(CCHWG\)](#) to invite your committee to provide feedback on the Zero Draft of the CCHWG's [Outline of Climate Change and Cultural Heritage](#). The purpose of this Outline is to comprehensively scope the intersection of cultural heritage and climate change and to inventory the types of impacts climate change is having on all types of heritage. The work of every ISC and indeed the work of every heritage professional has a climate change dimension. With your help, the CCHWG hopes the final Outline will capture all of them. The CCHWG launched the Outline project both to define its own remit and, more broadly, to help heritage actors understand their role in climate action and vice versa. [CCHWG members](#) worked for more than six months in order to produce the current draft, including [a scoping session held in Manama, Bahrain](#) in July.

The Zero Draft is now being shared for peer review: [Outline of Climate Change and Cultural Heritage](#). Each NC and ISC is invited to provide feedback as part of this process.
