A Message from US/ICOMOS Board Chair Douglas Comer: Help us Find our Next Trustees

Dear Members and Friends of US/ICOMOS,

It has been an honor to serve as Chairman of the Board of Trustees of US/ICOMOS since October 2016. As events around the world and here at home have us constantly re-evaluating our vision, strategies, abilities and effectiveness in accomplishing our important work, the leadership of US/ICOMOS must evolve.

Among the most significant ways to strengthen our organization is to build our 21-person board. US/ICOMOS is fortunate to have a working board where each member makes major contributions to the programmatic and fiscal advancement of the organization. In 2018, up to four vacant trustee positions will be filled.

The US/ICOMOS Nominating Committee welcomes your nomination of candidates to fill the positions. In selecting trustees, US/ICOMOS strives to maintain a diversity of backgrounds, experiences and geography. Emerging professionals and individuals with expertise in development and communications are especially welcomed. A list of qualifications for trustees can be found here.

The Nominating Committee urges US/ICOMOS members to forward nominations of qualified persons to the Committee at nominations@usicomos.org by May 1st. The nominations should include: (1) an email from the nominator, (2) the nominee's short biography (not to exceed one page), and (3) the nominee's statement of goals if elected and a description as to what makes him or her a qualified candidate (not to exceed 250 words). The Nominating Committee will then prepare a slate of candidates for consideration by the Board, and the approved slate will be sent to the membership for their vote.

ISC In Depth: ICAHM

Throughout 2018, we will feature one International Scientific Committee (ISC) per month in *US/ICOMOS at Work* in order to highlight the work of the ISC and provide potential members with information about how to join. Please note that in order to be considered for ISC membership, you must first be an International member of US/ICOMOS. If you have not yet joined ICOMOS for 2018, you can join here.



This month's ISC is ICAHM, the International Committee on Archaeological Heritage Management, described by ICAHM President, John Peterson.

1. Tell us your name, occupation, employer and few words about your interest in ICAHM.

Dr. John A. Peterson. I am Assistant Vice President for Graduate Studies, Research and Sponsored Programs at the University of Guam and former Director of the Micronesian Area Research Center. I have been active in Museum Studies in Texas and in the Philippines, and was Director of a Living Historical Farm and Agricultural Museum in Ohio as well as having contributed to the initiation of the Kabilin Heritage Center at the University of San Carlos Museum in Cebu, Philippines.

2. Tell us about the work of ICAHM in a few sentences.

ICAHM provides leadership for stewardship of archaeological world heritage, promotes conservation and heritage management strategies, supports nomination to tentative lists and World Heritage (WH) nominations, coordinates membership around central themes of heritage management, sponsors annual meetings and conference sessions, and publishes relevant topics for general readership (19 volumes in print with Springer Press).

3. What are the qualifications for membership in your committee and how should potential members apply?

Members should have a solid grounding in archaeology but also in the management of archaeological heritage. Expert and Associate members will combine both interests and experience, having a special connection to the management of archaeological heritage and especially where it is focused on the archaeology.

- Expert members must demonstrate the following: membership in ICOMOS; competency in archaeological heritage management with a reasonable degree of professional experience; sufficient educational training; and, most importantly, willingness to participate in the activities of ICAHM.
- Associate members (non-voting) are members of ICOMOS who wish to build up their interest and expertise in the field of archaeological heritage management.
- Affiliate members may have broader backgrounds and interests. Those with skills in museums, historical structures, and cultural landscapes will be interested in ICAHM where archaeological sites intersect with those themes.

For Expert and Associate levels, ICOMOS membership is required but anyone interested can join as an Affiliate. More information and an application are available at this link.

4. How do members participate in ICAHM (meetings, online conversations, etc.)?

Annual meetings, Society sessions, ICOMOS meetings, website, email lists for executive board and for membership,

5. Once they have been accepted, how do you recommend new members get involved?

New members can participate in meetings and can contribute to monitoring efforts of need for support for new inscriptions and management topics with existing WH sites with archaeological components.

6. Is there anything else that you would like prospective members to know?

ICAHM has the largest membership among the ISCs. This is due partly to outreach by former co-Presidents Comer and Willems and partly to the urgently needed mission for heritage preservation in the face of global threats from terrorism, climate change, and misanthropic governments. Archaeological components of existing WH sites have often been unrecognized and unmanaged, but new focus by the Salalah Doctrine provides the tools to redress that. New sites with archaeological components can be scrutinized to address those needs; new site inscriptions for primarily archaeological sites and landscapes can be developed and supported in individual member States of ICOMOS/WH.
