#### United States Announces 2018 Withdrawal from UNESCO

It is very unfortunate, but not a total surprise, that we find ourselves confronting <u>the likely prospect of the United States</u> <u>withdrawing from UNESCO as of December 31, 2018</u>. It may not be much consolation, but we have been here before between 1984 and 2003, and we have survived and prospered.

The US/ICOMOS Executive Committee and Board will be working with ICOMOS and legal experts to understand the full range of

- implications. For now, nothing has changed with regard to
- US/ICOMOS as a 501(c)(3) organization recognized as the U.S. National Committee of ICOMOS and fully engaged with ICOMOS as

a voting member looking forward to the General Assembly in Delhi. We will continue to aggressively solicit renewing and new members and our relationships with other National Committees--activities which have been made more important in light of Secretary Tillerson's announcement.

These events have also brought additional relevance to our <u>Leadership Forum scheduled</u> <u>for November 29-30</u>, to which Secretary Tillerson and Secretary Zinke have been invited to join Marie-Laure Lavenir, (Director General of ICOMOS) and Mechtild Rossler (Director, World Heritage Center, via teleconference). Please plan to attend.

At times like this one looks for any hopeful signs. Such a sign can be found in the words of <u>the State</u> <u>Department release</u>:

The United States indicated to the Director General its desire to remain engaged with UNESCO as a non-member observer state in order to contribute U.S. views, perspectives and expertise on some of the important issues undertaken by the organization, including the

protection of world heritage, advocating for press freedoms, and promoting scientific collaboration and education.

Irina Bokova, current Director-General of UNESCO, has released a statement regarding U.S. membership that you can read on our website. We will work to keep you informed of any significant news or developments as we learn them.

Africa Initiative Discussed at International Scientific Committee on Archeological Heritage Management (ICAHM) Meeting in Bagamayo, Tanzania



Doug Comer, President of US/ICOMOS and ICAHM, recently led ICAHM's 2017 meeting in Bagamayo (Dar-es-Salam), Tanzania, on the theme "Sub-Saharan Africa and International Trade Routes." Bill Pencek, US/ICOMOS Executive Director, attended as well and Grant Gilmore, US/ICOMOS Board Member, presented "Back to Africa, The Trade in Ceramic and Aluminum Coalpots in the Atlantic World" during a session devoted to trade routes.



During the meeting, Doug Comer led the first of two substantive discussions about an initiative in which well-established national committees from around the globe assist sub-Saharan African nations to formulate national committees or strenthen these where they already exist. Participants from longtime national committees will provide guidance on protocols, successful programs and initiatives, and ideas for funding sources. Beyond moving world heritage management and designation initiatives forward in sub-Saharan Africa, the initiative will provide a rare forum for national committees new and old to share ideas that can be utilized by all nations to strengthen the World Heritage movement.
