

2020 in Retrospect

A Message from Douglas C. Comer, Ph.D., US/ICOMOS President



The year behind us, 2020, is one that presented challenges unlike those anyone alive today can recall, for US/ICOMOS and for the world. But it is at moments like this that we are forced to confront the issues that have brought us to this point of international and intercultural fragmentation, discord, and conflict.

It was in fact at a moment such as this, at the end of World War II that the United Nations was formed. [....] Most of the people alive

today have forgotten the terrible lessons learned from those world wars that arose from a perfect storm of economic inequality and racial intolerance. We find ourselves again in a whirl of conspiracy theories that portray "others" as contriving threats, convincing many to rally behind those who attempt to project strength and the ability to bring back an imaginary golden age by making vile accusations.

It has become clear to us at US/ICOMOS that we share a moral responsibility to restore international and intercultural understanding. We deal in heritage. What does heritage have to do with it?

International and intercultural understanding

Heritage is what we take from what happened in the past, and heritage determines what happens in the future because it is what builds our communities and our identities. Heritage is the foundation: what we grow out of, who we are, and who we will be.

Year in Review: World Heritage Advocacy in 2020

2020 was a tough year for many of our issues, beyond the effects of Covid-19. Congress remained in stalemate between House and Senate, so we had no chance to get a bill enacted to allow State Department to pay the USA's back dues to the World Heritage Center, which certainly will slow, if not stop, momentum for any inscriptions of new U.S. World Heritage sites until this impasse is resolved. On the positive side,

thanks largely to Trustee Tom Cassidy's lobbying efforts, the House FY 2021 Appropriation bill for Interior urged the National Park Service (NPS) to prioritize funding for needed deferred maintenance work in the 19 U.S. World Heritage Sites that are managed by NPS.

We joined with many of our preservation and conservation colleagues in opposing the Bureau of Land Management (BLM)'s major oil and gas leasing plan for public lands that surround the Chaco Culture National Historic Park and World Heritage site that would even more negatively impact numerous Chacoan "outliers" that are archeological sites on BLM land also included in the World Heritage site boundary.

- We supported legislation to establish a 10-mile no-leasing zone on BLM lands around Chaco, which passed the House by a wide margin, but has thus far not moved ahead in the Senate.
- We helped raise awareness about the risks to Chaco in our September 10 World Heritage Webinar "World Heritage Site at Risk: Chaco Culture National Historical Park" (pictured above).
- In an effort to prepare the incoming administration, we have signed on to and shared a memo entitled <u>"Recommendations on Planning for and Managing Oil & Gas Leasing</u> and Development in New Mexico's Greater Chaco Region."

We thank our members, partners and everyone else who has joined us in these efforts and

will continue to keep you apprised of our actions. 2021 International Exchange Program (IEP) Update

All of us on the US/ICOMOS IEP Committee are encouraged by the recent news of a vaccine, and we are hopeful that the 2021 IEP can go forward as planned. However, as the global coronavirus pandemic continues, the final fate of the 2021 IEP remains uncertain.

The IEP Committee is committed to holding the 2021 program in-person and on time (end-May through mid-August), but will only do so if it is safe for all host and intern participants. We remain committed to working with those participants who were ready to take part in the 2020 program until the pandemic forced us to cancel it. We therefore are not accepting any new applications for hosts or participants for 2021.

After the new year, we will check in with the 2020 participants and confirm their interest and ability to take part in 2021. We will then consult with the Smithsonian Institution's Office of International Relations (program sponsors for the J-1 exchange visas) to come up with a revised timeline for the 2021 program.

ICOMOS Declares a Climate Emergency

The planet is at a crossroads where business as usual is no longer on option. This week the 20th ICOMOS General Assembly overwhelmingly voted to declare a Climate and Ecological

Emergency.

Meeting during the 5th anniversary of the Paris Climate Agreement, the declaration recognized that the world is failing to meet the Paris targets and that adverse impacts on cultural heritage are already being felt. It calls for urgent collective action to safeguard heritage from climate change through a precautionary approach that pursues pathways for limiting global warming to 1.5°C.

The declaration also recognizes the immense potential of cultural heritage to enable inclusive, transformative and just climate action. It calls on the ICOMOS community to work to realize this potential and to seek to safeguard all types of heritages from adverse climate impacts, implement risk-informed disaster responses, deliver climate resilient sustainable development; and recognize equity and justice as fundamental dimensions of climate action.

ICOMOS also pledged to actively promote the theme of climate change and cultural heritage as the core topic of its Triennial Scientific Programme and to work to reduce its own carbon footprint.

The resolution was spearheaded by the ICOMOS Climate Change and Heritage Working Group and sponsored by a number of ICOMOS national committees and international scientific committees as well as ICOMOS members from around the world. US/ICOMOS contributors included Andrew Potts (ICOMOS Climate Change Working Group Focal Point), Patricia M. O'Donnell, Greg De Vries, Milagros Flores (Puerto Rico), Pamela Jerome, Adam Markham, and Chris Marrion.
