Monuments Toolkit

Your Assistance Needed: Monument Relocation, Removal, and Reinterpretation Toolkit Work Begins

US/ICOMOS announced on September 28th that we received [a \\$1 Million grant from the Andrew W. Mellon Foundation to support the development of a Monument Relocation, Removal, and Reinterpretation Toolkit \("Monuments Toolkit"\)](#). Work has already begun and we need your assistance in our search for:

1. **Advisory Panel Recommendations:** the Advisory Panel will provide guidance and support for staff hired to undertake this project. It will be composed of subject matter experts, long-standing and well-known professionals in the heritage sector, regional experts, and thought leaders. If you would like to recommend a candidate to serve on the Monuments Toolkit Advisory Panel, please email your recommendation to [monumentstoolkit \[at\] usicomos.org](mailto:monumentstoolkit@usicomos.org).
2. **Monuments Toolkit Program Director:** US/ICOMOS seeks a full-time (40 hours/week) Program Director for a two-year appointment to manage the Monuments Removal, Relocation, and Reinterpretation Toolkit Project. The Program Director will be responsible for collaborating with the US/ICOMOS Monuments Team to oversee all aspects of the US/ICOMOS Monuments Project. **The application deadline for the Program Director position is October 30, 2021.**
3. **Monuments Toolkit Media and Marketing Program Assistant:** full-time (40 hours/week) Program Assistant for a two-year appointment. The Media and Marketing Program Assistant will focus their work on creating digital content for the Monuments Project and develop public-facing programming.
4. **Monuments Toolkit Publications, Research, and Administration Program Assistant:** full-time (40 hours/week) Program Assistant for a two-year appointment. The Publications, Research and Administration Assistant US/ICOMOS seeks a full-time (40 hours/week) Program Assistant will oversee the written publications and research for the Monuments Toolkit program.
5. **Part-Time Monuments Toolkit Program Assistant:** Three part-time Program Assistants will be hired in the DC area and remotely from locations around the country to work approximately 20 hours per week on the project, conducting research, writing and other tasks. These two will be two-year appointments.



Frank Lloyd Wright and World Heritage in the United States: Taliesin and Taliesin West

Part Three in a series about “The 20th-Century Architecture of Frank Lloyd Wright” World Heritage listing.



“The 20th-Century Architecture of Frank Lloyd Wright” World Heritage listing includes two of the architect’s personal residences and architecture studios: Taliesin in Spring Green, Wisconsin, and Taliesin West in Scottsdale, Arizona. Designed, constructed and reconstructed over decades beginning in 1911 (Taliesin) and 1938 (Taliesin West), the two sites embody Wright’s career-long development of an organic modern architecture intimately connected to landscape. Both sites are owned and stewarded by the Frank Lloyd Wright Foundation, which maintains and preserves the buildings at Taliesin and Taliesin West, along with Wright’s intellectual property.


Born in Texas to enslaved parents, Felix Haywood had an intimate understanding of the Underground Railroad Movement in Texas and Mexico.

Even though Haywood did not escape to Mexico himself, he knew individuals who self-liberated by traveling across the Rio Grande to Mexico. Many nations around the world are connected to Underground Railroad history. If you know of additional stories where

The Preservation Priorities Task Force is a group of preservation advocates from across the country who came together to develop a series of publications on key issues facing the preservation movement. These Issue Briefs cover the following topics:

- Affordable housing and density
- Diversity, inclusion, and racial justice
- Preservation trades and workforce development
- Sustainability and climate action

Preservation organizations and advocates are encouraged to use the Issue Briefs in any number of ways— as guides for discussions with community leaders and stakeholders, background for outreach to potential partners, support materials for fundraising efforts, and more.
